- The schedules will be extended if the applicant fails to address staff's plan review comments, post zoning signs in accordance with the sign ordinance, or if the Planning & Zoning Commission and/or the Town Council tables the request.
- * 30 Day Waiver required with submittal.

- **Note, the November 22nd & December 27th Town Council meetings are subject to cancellation due to holidays.
