## Event Information

- April 5, 2025, noon – 10:00pm
- Entertainment
  - Adam Hood (headliner)
  - Chattahoochee (opener) - has played for Prosper Ladies Association's Boots and Bling
  - Third band being considered
- Alcohol served by Downtown Businesses (same model as Freedom Fest)
- Event to be produced by Bekah Hardick
  - Proprietor of Inappropriate Trucker Hats) – successful event in 2023
- Vision is to bring the Downtown businesses together to provide a celebration for the residents of Prosper
- Event name proposed – 'Downtown Block Party hosted by Uncle Bekah'
- Unique opportunity for the Town to partner with Downtown businesses



## Town Obligations

- Title Sponsor Status - \$30,000
- Trash Carts and Recycling Carts
- Agreed upon social media/website promotion timeline, including platforms to be utilized and frequency of posts according to sponsorship promotional obligations (to include FAQ page, Facebook Event)
- Town of Prosper staffing for the day of event logistics (Parks and Recreation - Litter Management) (Public Works - Site and Traffic Control) (Police and Fire – Safety) (Health Department - Food Permits)
- EDC has expressed interest in potential partnership if Town participates pending board approval
