


## Purpose:

  - Building 4: Restaurant (9,322 SF) + Patio (2,212 SF)







- Add eight temporary buildings totaling 12,288 square feet to an existing middle school.


## Zoning Ordinance:

# → Emergency Services District

→ ~350 ESDs in Texas

Commissioners Court appoints Commission members (5 total) to staggered two-year terms

ESD Board of Commissioners adopts the tax rate and sets the budget annually after the Commissioners Court sets the initial rate

- \$0.10 constitutional cap on tax rate
- 3.5% voter-approval rate




Above demonstrates the range of possible ESD levy. If all cities allow their ETJ to be included in the ESD boundaries and MUDs are part of the ESD, there is \$23.2 billion in taxable value. If all cities do not allow their ETJs to be included in the ESD boundaries, the lowest taxable value is \$3.3 billion.

- Additionally, ESD voters can approve up to a two (2) cent sales tax in the unincorporated area.

# Emergency Services District



- Texas Constitution, Article 3, Section 48-e
- Health and Safety Code Chapter 775 Petition
  - with metes and bounds description of the district signed by 100 eligible residents
  - Commissioners Court receives and calls
    - the election
  - Cities have 60 days to determine if ETJ is
    - included in the ESD
  - Existing MUDs, if included in the
    - petition, can be part of the ESD





# Gap Year

- ESD Election – November 4, 2025
- Fire District Gap Year – October 1, 2025 – Sept. 30, 2026
- ESD Budget Effective – October 1, 2026
- Tax Collection – January 31, 2027



# Financials

- Collin County Commissioners will determine ESD Tax Rate
- Emergency Service District Board would determine how the funding would be distributed.
- Current discussions are towards establishing \$.075 per \$100
- Fiscal Year 2025 County Payment is \$260

# Prosper Revenue Estimates

- Current - \$260 Revenue
- 3 cents per \$100 - \$1360
- 5 cents per \$100 - \$2464
- 7.5 cents per \$100 - \$3849
- 10 cents per \$1000 - \$5241
