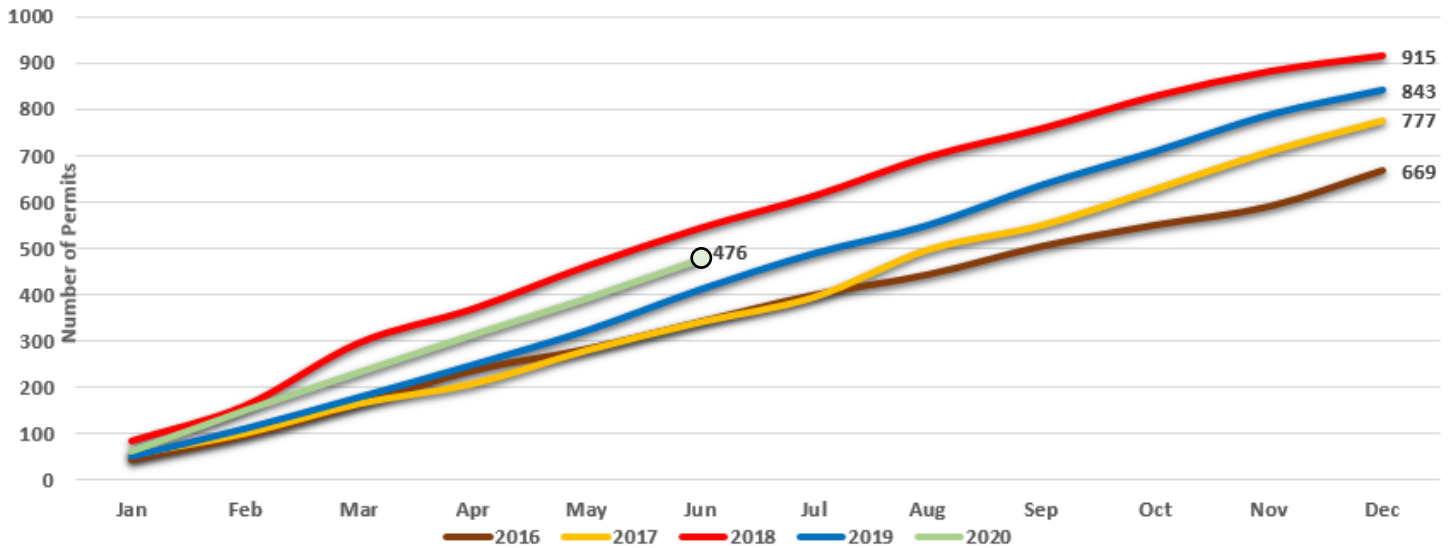

## **Town Council Approves Silo Park Zoning Amendment**

On June 23rd, Town Council approved a zoning amendment for the Silo Park Food Truck Park, located on the southeast corner of Fifth Street and McKinley Street. When the zoning was originally approved in 2017, it permitted the food truck park use for an initial period of three (3) years with temporary improvements including parking lot surfacing, building materials, and landscaping. The recently approved zoning amendment allows the food truck park use for an indefinite period of time and requires parking lot improvements within three (3) years. The amendment also introduces a ‘restaurant incubator’ concept to the food truck park. The zoning allows for two (2), ten-foot by twenty-foot (10’ x 20’) incubator structures which would accommodate emerging restaurateurs.
