Prosper FD Fireworks Display Guidelines and Submittal Requirements

A completed permit application along with the following information is required to promote or execute all commercial or consumer firework displays within the Town of Prosper:

- A site plan of the grounds where the display occurs must be submitted and approved by the Fire Marshal in PDF format
- Provide the number of personnel to be utilized for security purposes at the launch site and fall-out zones
 - Provide the first & last names of the personnel assigned for security purposes
 - If security is delegated to the special event sponsor, please obtain all prescribed information identified above and include said information in the application
- A copy of the company's state registration issued by the State Fire Marshal's Office (Commercial only)
- A copy of a pyrotechnic operator license issued by the State Fire Marshal's Office (Commercial only)
- A list of the fireworks utilized in the display along with an MSDS for each (Commercial Only). Consumer Displays are restricted to ground devices containing 50mg or less of explosive composition and smoke devices classed as explosive 1.4G, firecrackers, and small smoke bombs only.
- Provide a certificate of insurance for a minimum of \$1,000,000 bodily injury and \$500,000 property damage, if the display is aerial. Non-aerial displays must have a certificate of insurance for a minimum of \$500,000 bodily injury and \$300,000 property damage insurance. Identify the Town of Prosper as co-insured on the policy.
- A \$250 permit fee (check made out to The Town of Prosper) and permit application form from the Fire Marshal's office is required. The application is located on our web page at www.prosper.tx.gov/fire-department/fire-marshal/ under the "Fireworks Display and Hazardous Transportation Permit Application"
- If requesting a public display permit for 1.3G Explosives, include the State Fire Marshal's Office required permit (Commercial only).
- Alternatively, a notarized letter on company letterhead citing Texas Occupations Code, Chapter 2154, Regulation of Fireworks & Fireworks Displays utilizing 1.4G Explosive is exempt from the Texas State Fire Marshal's office requiring permit issuance.

We must receive all information for review and approval for aerial fireworks at least 21 days before the scheduled event. Review & approval for flame effect, open flame performances, etc., at least 14 days before the scheduled event. The public display must meet all State of Texas requirements as outlined in the Texas Occupations Code Sec. 2154.206, Chapter 2154.
