

Serve on Town of Prosper Boards & Commissions

Apply by August 3, 2020

How does it work?



Town boards and commissions are an important way for citizens to participate in local government by shaping public policy and recommending local legislation.



In Prosper, members of these appointed groups advise the Town Council on a variety of topics including planning, zoning, building standards, parks, and libraries.



Members of Town of Prosper boards and commissions are unpaid volunteers. Any registered voter with one year of residency in Prosper is eligible to apply.



Board and commission members are subject to attendance requirements, and the Town's Code of Ethics Ordinance. The Town of Prosper Board and Commission Appointment Policies and Procedures are located at <https://www.prospertx.gov/government/boards-commissions/>.

How do I apply?

Thirteen positions will be considered by the Town Council for appointment. Applicants are encouraged to attend at least one meeting of the board or commission they wish to join. The application deadline is August 3, 2020.

All applications received, including those from incumbents, will be reviewed and considered for interview. Interviews are typically held in late August and/or early September. Appointments are made in September and are effective September 30, 2020.
