<ol style="list-style-type: none"> 1. Shall be at least eighteen (18) years of age at the time of the election for which they are filing. 2. Shall meet the requirements to be a qualified voter set forth in the Texas Election Code. 3. Be a registered voter in the Town of Prosper for at least twelve (12) months immediately preceding the filing date. 4. May not file for more than one (1) office or position as provided by the Town Charter. 5. The office of an incumbent elected Town official shall become vacant when the person holding such office files an application to have his or her name placed on an official ballot as a candidate for any elective public office other than the one such person holds, unless otherwise prohibited by law. 6. Shall comply with all other Town ordinances or resolution that may be applicable. 	February 18, 2022 by 5:00 PM
